- 2. The members filing nominations from reserved constituencies are required to submit valid Cast Certificate certified by Competent Officer along with nomination form.
- 3. The decision of the Election Returning Officer shall be final in respect of validity of nomination forms.
- 4. The Election Returning Officer shall publish list of election centres on notice boards of Head Officer as well as all branches within reasonable time.
- 5. As per section 39(1)(o) of the Multistate Cooperative Societies Act, 2002, the election program is being conducted in the General Meeting to facilitate voting of members. The attendance of the voting members shall be considered as attendance of the meeting.
- 6. All the eligible members of the Society shall vote to elect 14 members of the Board of Directors.

- 7. The member shall carry photo identity (any one of IDs applicable to General Elections) at the time of voting.
- 8. The list of members of the Society shall be published at Head Office and all the branches of the Society. Any member can obtain such list by paying Rs. 75,000/-
